Memorandum of Understanding - Military Tuition Scholarship -

Congratulations on your decision to continue your educational goals with Grand Canyon University. In keeping with the University's long-standing tradition of providing excellent educational programs, we are excited to offer you the **Military Tuition Scholarship**. This scholarship is only valid for those applicants who submit a complete application and commit to continuous enrollment.

In an effort to support those who are currently serving or have served, we will offer a scholarship that will reduce tuition for undergraduate or certificate students to \$250.00 per credit and for graduate seeking students to \$350.00 per credit hours to the following groups:

- Active Duty Military and Spouses
- Veterans and Veteran Spouses
- Active Reserve/Guard
- Retired Military and Retired Military Spouses

We are pleased to extend this scholarship to you however, you must meet these minimum requirements; in an *undergraduate or graduate online or remote program (excluding programs on our traditional campus)*, you must maintain Satisfactory Academic Progress (minimum 2.0 GPA) as indicated in the University catalog throughout your program; in a *graduate/certification program*, maintain Satisfactory Academic Progress (minimum 3.0 GPA) as indicated in the University catalog.

By approving this document, you understand that you will be billed at the regular tuition rate for the duration of your Program of Study; however, your scholarship will reflect the difference in tuition. This special military tuition rate is only applicable to students who can provide one of the following supporting documents:

- Letter from Commanding Officer
