MEMORANDUM FOR The Military Personnel Officer, All States

SUBJECT: Procedures for Volunteering Retired Active Guard Reserve (AGR) 79Ts Reenlisting in the Army National Guard (ARNG) (ARH Memo 05-028)

1. References:

- a. Title 10, United States Code Armed Forces.

2. The purpose of this memorandum is to provide guidance on AGR 79T retirees who volunteer to reenlist in the ARNG with the intent of augmenting the Joint Forces Command Headquarters to support the Recruiting and Retention Force.

3. The Secretary of the Army's approval is required to reenlist ARNG members retired under Section 3914 of Title 10, U.S. Code (enlisted soldiers retired and receiving retired pay). Retired 79T AGR Soldiers desiring to reenlist will be placed in the Ready Reserve under the authority of Title 10 U.S.C 10145(d) and AR 140-10, Chapter 6. Once a retired ARNG Soldier is placed in the Ready Reserve, he or she can then reenlist in the ARNG.

4. Guidance and administrative instructions to support increased manning initiatives are addressed in the above reference (1.d.).

5. Retired Enlisted Soldiers may be used to fill shortages in or to augment the Joint Forces Command Headquarters at each State or Territory in support of the Recruiting and Retention mission. Enlisted soldiers that wish to volunteer for reenlistment with a specific unit must submit the following documents to NGB-ARH, (SGM Frances Burke), 1411 Jefferson Davis Highway, Suite 3901, JP1, Arlington, VA, 22202-1382 or may be faxed to NGB-ARH at (703) 607-3578:

SUBJECT: Procedures for Volunteering Retired Active Guard Reserve (AGR) 79Ts Reenlisting in the Army National Guard (ARNG)

a. A request from the Soldier volunteering to reenlist into the ARNG (applicant must be less than 55 years of age in order to be eligible for an enlistment waiver (ECM table 2-2, line 46)).

b. A statement from the State TAG/ATAG in support of the Soldier's request. The statement should include a by-name request, UIC of the unit, paragraph and line number and strong justification supporting the retiree's request for reenlistment, explaining the Soldier's essentiality. The request must be signed by the TAG/ATAG and include a point of contact (POC), listing a commercial phone number and DSN, if available.

c. Applicants over the grade of E-6 must be MOS qualified (79T). Also, the State CSM must provide an endorsement of the application for grades E-6 through E-9 (ECM Table 2-2 line T).

d. A statement from the retired Soldier regarding receipt of retired pay (whether or not receiving).

e. A copy of the State Retirement Order.

f. A completed DA Form 160-R, Application for Active Duty. Current Height and Weight must be added in item 13. The form must be signed and dated.

g. A current copy of a MEPS physical (ECM Para 2-18, Physical).

h. Verification of Security Clearance from the State Personnel Security Manager.
