SUBJECT: Policy Memo #02-05, ASVAB Scores for MOSQ Training

1. This memo provides guidance for required ASVAB Scores to attend MOSQ Training based on Interim Change to TRADOC Regulation 350-18 dated 26 May 00 and DA PAM 611-21.
2. All Soldiers who attend MOSQ training will have the minimum ASVAB score as outlined below:



3. Commanders **must** request a waiver for Soldiers who do not meet the minimum ASVAB requirements based on the MOS. The waiver will be based on the Soldier's performance and experience level.
4. Units must receive **concurrence** from the Field Artillery Proponency Office prior to the Soldier attending the course. A copy of the approved concurrence will be attached to the pre-execution checklist and accompany the Soldier to the training institution. The waiver will become part of his official student record. Failure of the chain of command to obtain the concurrence prior to their Soldiers attending training will be cause for non-enrollment in the course.
